Across every report, testimony, and on-the-ground account, a clear and troubling pattern emerges: **DHS enforcement overreach is harming U.S. citizens, lawful residents, and children.** Documented incidents have included:

- **Warrantless arrests and unlawful detentions**
- **Use of force in residential and civilian settings**
- **Detention of U.S. citizens, Native Americans, and Puerto Ricans**
- **Enforcement actions impacting schools and children — including U.S. citizen minors**
- **Breakdowns in due process**, including cases involving individuals with lawful status or pending relief

These are not isolated events — they reflect systemic failures in accountability, oversight, and adherence to the most basic standards of due process and public safety.

This Immigration Enforcement Accountability Resource Hub brings together core materials that partners can use to help illuminate these harms, elevate community experiences, and support congressional efforts to re-establish checks on DHS enforcement practices.

### [UnidosUS's 2025 Bipartisan Latino Voter Poll](#)

Shows overwhelming concern about excessive force and wrongful arrests, with 85% of Democrats and 62% of independents disapproving of ICE's performance, underscoring broad alarm over unchecked enforcement and civil rights violations.

Demonstrates that Americans view Trump's policies as making the *country poorer, weaker, and less safe*—reinforcing broad public concern about economic instability and aggressive enforcement tactics.
