INTRO TO RDF

Raza Development Fund, Inc. ("RDF") is a Latino-led and serving Community Development Financial Institution ("CDFI") formed in 1999 by UnidosUS, (formerly, National Council of La Raza), the country's largest and longest-serving Latino civil rights and advocacy organization.

RDF was created to advance economic opportunity, social mobility, and racial justice.

Since inception, RDF has directly invested over a billion dollars in 38 states, leveraging over \$6 billion in the areas of education, affordable housing, healthcare, social services, and entrepreneurship.







We embed clean energy, greenhouse gas reduction tactics and other climate adaptations into the projects in which we invest in order to help vulnerable Latino/a/x communities become environmentally, socially and economically sustainable and resilient.

STATUTORY BASIS FOR OEJECR IRA GRANTS

The Environmental and Climate Justice Grants (ECJ) program was created by the Inflation Reduction Act and is contained in Section 138 of the Clean Air Act with flexibility for program design within the following parameters:

- <u>Funding</u>: Approximately \$2 Billion for the ECJ Change grants. An additional \$200 million is available to provide TA for the IRA funded grants.
- Period of Performance: The grants cannot exceed three years. No extensions afforded.
- Eligible Entities For the Grants:
 - A partnership of <u>community-based non-profit organizations</u> (CBO)
 - A partnership between a CBO and a <u>federally recognized Tribe</u>, a local government, or an institution of higher education

Other organizations and entities may be able to participate and be involved in the Community Change Grants projects as collaborating subrecipients

STATUTORY BASIS FOR OEJECR IRA GRANTS

Grants can be for the following activities:

- Community-led <u>air and other pollution</u> monitoring, prevention, and remediation, and investments in low- and zero-emission and resilient technologies and related infrastructure and <u>workforce development</u> that help reduce greenhouse gas emissions and other air pollutants;
- Mitigating <u>climate</u> and health risks from urban heat islands, extreme heat, wood heater emissions, and wildfire events;
- Climate resiliency and adaptation;
- Reducing indoor toxics and indoor air pollution; or
- Facilitating <u>engagement</u> of disadvantaged communities in State and Federal advisory groups, workshops, rulemakings, and other public processes.



Project / Award Categories

The NOFO will have <u>two</u> tracks

- Multi-Projects: Multifaceted holistic vision of projects addressing a variety of environmental and climate justice challenges along with education, engagement, workforce, capacitybuilding efforts
 - Applications must address some combination of categories (climate / pollution / workforce development) to make it multifaceted and of greatest benefit to communities
 - \$10-20 M award range
- Engagement-specific "Government Equity" projects: Projects that focus specifically on advancing meaningful engagement between communities and government processes / institutions
 - Facilitate the engagement of disadvantaged communities in governmental processes (e.g., permitting advisory boards and ECJ academies)
 - \$1-3 M award range

Reduce emissions of greenhouse gases and other air pollutants

Tackle the climate crisis and protect public health by supporting the climate goals of the US and achieve net-zero emissions by 2050



Deliver benefits to ALL communities - especially low income and environmentally disadvantaged communities

Maximize the benefits of GGRF investments - such as energy bill savings, pollution reduction, and workforce development



Mobilize financing and private capital to stimulate additional investments

Catalyze market transformation by addressing the barriers to mobilizing private capital into clean projects in undercapitalized markets




GGRF: NCIF Flow of Funds

EPA will award grants to 2-3 national nonprofit financing entities to create national clean financing institutions capable of partnering with the private sector to provide accessible, affordable financing.

At least 40% of program funds must be used for the purpose of providing financial assistance in low income and environmentally disadvantaged communities.

National Clean Investment Fund grant recipients develop long-lasting programs that:

- Provide financing to individuals, families, nonprofits, businesses, and others deploying qualified projects
- Provide financing to community lenders and other similar institutions so that they can, in turn, provide financing to the communities that they serve
- Support predevelopment and market-building activities that are reasonable and necessary to deploy financial assistance to qualified projects
- Mobilize private capital, with each dollar of public funds generating several times more private investment



GGRF: CCIA Flow of Funds

EPA will award grants to 2-7 hub nonprofit that will provide funding and technical assistance to public, quasipublic, not-for-profit, and nonprofit community lenders.

100% of program funds must be used for the purposes of providing financial and technical assistance in low income and environmentally disadvantaged communities.




Clean Communities Investment Accelerator grant recipients develop long-lasting programs that:

- Provide capitalization funding (up to \$10M, unless EPA provides an exception) to community lenders, which could include community development financial institutions (including Certified Native CDFIs), credit unions, green banks, housing finance agencies, minority depository institutions, and others
- Provide technical assistance subawards (up to \$1M, unless EPA grants an exception) as well as technical assistance services to community lenders
- Focus exclusively on CCIA-eligible projects, which are qualified projects in three priority project
 categories (distributed energy generation and storage, net-zero emissions buildings, and zero-emissions
 transportation) that are in low-income and disadvantaged communities

GGRF: 3 Priority Project Categories




DISTRIBUTED ENERGY GENERATION AND STORAGE

Projects, activities, and technologies that deploy small-scale power generation and/or storage technologies (1 kW to 10,000 kW) (Residential, MF, Commercial, Community Services)



NET-ZERO BUILDING EMISSIONS

Projects, activities, and technologies for (1) retrofits of existing building making substantial contribution getting to net-zero over time or (2) construct new net-zero buildings (Residential, MF, Commercial, Community Services)



ZERO-EMISSIONS TRANSPORTATION

Projects, activities, and technologies that deploy zero-emissions transportation modes and enabling infrastructure, especially in communities that are overburdened by existing diesel pollution, particulate matter concentration, and degraded air quality.






